## What is your nationality?

• If you are a citizen of the EU/EEA or Switzerland, you must ask for a European health insurance card, before you come to France as proof of membership in a European health insurance scheme. you will submit this card to the health professionals and healthcare facilities you will go to.



## You are registered in our HealthCare (non-European students)

The national HealthCare covers around 70% of your medical expenditure.

You may then sign up for additional health insurance (Complémentaire Santé) for better reimbursement. This supplemental insurance is not compulsory but highly recommended. It will cover the remaining 30% of the medical expenses that are generally not covered by the compulsory health insurance.

It depends of your needs, your health, etc.

We recommend you to register at the SMERRA:

### For Europeans students

- You should always advance the fees and send the bill to our International departement of EHC in Grenoble with a copy of you ID, EHC and the bill:

#### I am sick, Where should I go? What should I do?

• All students can receive free medical services at the Centre de Santé Universitaire (University Health Center). A team of health professionals are there to assure a welcome, and offer regular consultations and preventive healthcare:

Medical consultations with general practitioners or specialists (gynecology, sexology, psychiatry, nutrition, addiction), Full nursing and vaccination services, Consultations with psychologists,

Medical consultations for students with disabilities (in the context of an adaptation to studies and exams, and in relation with the "Service Accueil Handicap"),

Planning centre (contraception, medical abortion, HIV testing)

All these services are available without initial payment. Make sure that you take with you:

Your student card,

Your 'carte vitale' (medical card) or your certificate of affiliation to Social Security and any complementary policy 'mutuelle', or your EHIC (European Health Insurance Card), or RAMQ form.

#### A few words about the CVEC

- Students admitted to a French institution of higher education for the 2018 academic year are subject to a new fee known as the CVEC, which helps to finance *on-campus programs that enhance the student experience* (€90 for academic year 2018/19).
- This fee is mandatory until you graduate from your French Higher Education i.e Grenoble INP-PHELMA,
